- All cattle must have RFID tags.
- Shows offered will be heifers, bulls, prospect steers, and cow/calf pairs.
- Exhibitors may show out of their trailers, or may make stalls in barn. **Exhibitors must clean stalls!!!** Generators are recommended.
- There will be no tie outs. Overnight cattle must tie out to or on trailer or in barn.
- Camping is available at \$20/night includes utilities. If you plan on camping please contact the Kent County Fairgrounds and make arrangements with them. 616-897-6050
